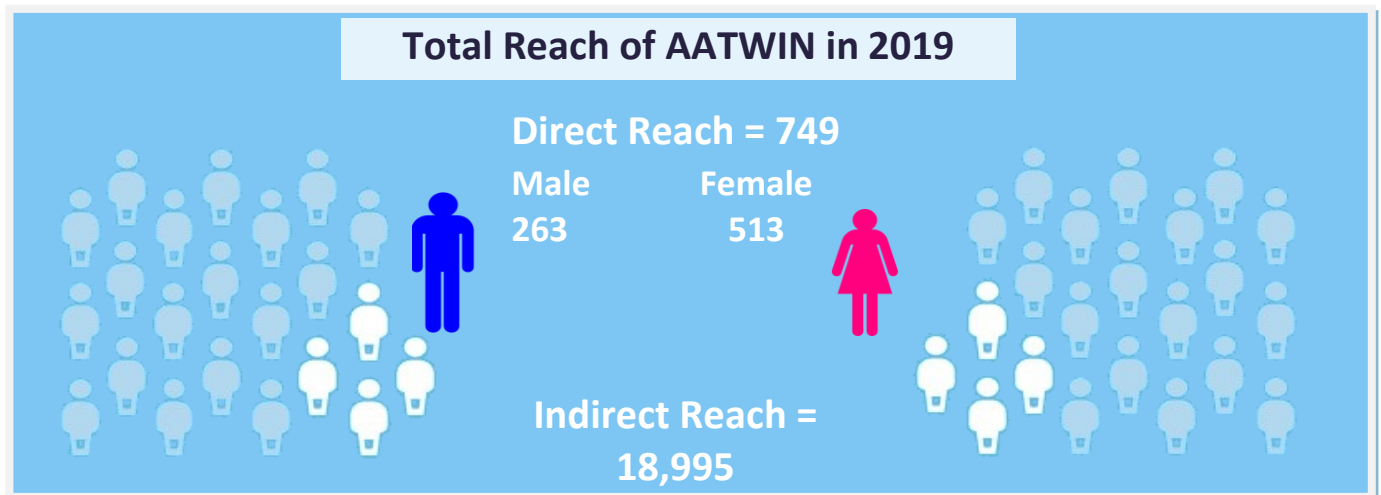
SUMMARY

The year 2019 was a remarkable year for AATWIN. AATWIN has been advocating for the ratification of Palermo Protocol for more than a decade. Finally this campaign gained a milestone on June 5, 2019 when the Council of Ministers decided to ratify the Palermo Protocol.

This year, AATWIN also got opportunities for new partnerships: Ministry of Women, Children and Senior Citizen (MoWCSC) and Plan International Nepal. AATWIN conducted a pilot survey to map vulnerability to human trafficking in two districts- Sindhupalchok and Makwanpur, this research was financially supported by MoWCSC. AATWIN and Plan International Nepal has undergone partnership for new project ProTECT which is a multi-year project countering human trafficking and issues of repatriation. AATWIN extended cooperation and coordination with the police, the private sector and the media against human trafficking.

In 2019, AATWIN and Shakti Samuha jointly organized the Fourth National Conference of Human Trafficking Survivors which formed a National level network of human trafficking survivors. The total of 103 survivors participated in the conference from all seven provinces of the country. AATWIN member organizations CWISH and KIN Nepal received honors and awards from Ministry of Women's Children and Senior Citizens on the occasion of 13th National Day Against Human Trafficking, in accordance with the recommendation of AATWIN.

AATWIN had its 16th AGM and 8th Convention in 2019 and the new Executive Committee was elected for the next two years. Ms. Natisara Rai of Shakti Milan Samaj, a trafficking survivor herself was elected as new chair of AATWIN. AATWIN's 3 years Strategic Plan was endorsed by this year's AGM on 25 September 2019. AATWIN was successful in reaching directly to 749 people through its programs and indirectly to 18,995 via IEC materials and others.



AATWIN as a Vice-Chair of National Action and Coordination Group (NACG), apex Body to South Asia Initiative to End Violence against Children (SAIEVAC) of SAARC contributed to the development of regional strategies related to online safety including child sexual abuse and exploitation as well as drafting of a national strategy through the NACG Nepal / SAIEVAC mechanism by the Ministry of Women, Children and Senior Citizens. The issue of human trafficking has been given due priority in the approach paper (Chapter 9, 9.13) of 15th Plan (FY76/77-80/81) of the National Planning Commission.

AATWIN had opportunities to advocate on various laws and regulations relating to human trafficking in the new structure of the state in 2019 for instance Human Trafficking and Transportation (Control) Act and Regulation. AATWIN interacted with regional and federal lawmakers against human trafficking and commercial sexual abuse of children. AATWIN was also involved in Beijing + 25 Review Consulting Reporting Process, 25th Plan of the National Planning Commission, SDGs, Universal Periodic Review (UPR), CEDAW and represented in various national, regional and international meetings.

However, AATWIN faced some challenges in the year 2019. Delay in the ratification of the Palermo Protocol and amendment in HTTCA 2007 has been a problem for all organizations working against human trafficking. In absence of additional laws against human trafficking such as trafficking victim/survivors' repatriation policy, AATWIN and other member organizations have been facing many difficulties in repatriation from India and third countries. The changing dimension of human trafficking, human smuggling and trafficking in name of foreign employment has also been huge challenge for the NGOs working against human trafficking. Obstruction in access to justice for the victims (Sun Bahadur Tamang case of Nuwakot) is a huge setback for the all working in this sector and very demotivating for the victims of trafficking to come forward for justice. AATWIN did carry on its movement for the justice to the victims. The provision of hardware and software made mandatory by the government for the development programs is also setback for organization like AATWIN whose main objective is to influence policies and advocacy.

ABOUT AATWIN

Alliance Against Trafficking in Women and Children in Nepal (AATWIN), a national level network of non-governmental organizations, was formally formed on 6 June 1997, to strengthen the campaign against human trafficking and for human rights; focused on women's and children's human rights.

AATWIN has adopted Human Rights-Based Approach in all its endeavors. It has been focusing, since its establishment, on policy changes to tackle human trafficking at the local, national and international levels. It has undertaken tireless efforts to bring conceptual clarity on issues of human trafficking not only amongst its member organizations but also in wider populations. AATWIN recognizes that human trafficking is a global phenomenon, and strongly believes that the national laws, policies, regulations and functional service guidelines including campaigns should reflect the international standards and practices. AATWIN aims to mobilize campaigns by joining hands together with as many as possible local, national and international organizations to fight against the issues pertaining to human trafficking.

Vision

- To establish a society of justice and equity free of human trafficking.

Mission

- To launch the strong campaign against human trafficking all over the country, organize and empower the organizations working in women's rights, human rights and child rights, coordinating with international networks, advocacy and lobby to reduce the heinous crime like human trafficking.

Goal

- To reduce human trafficking through changes in policy and awareness campaigns

Major Objectives

- To influence and support law- and policy-makers to formulate, amend and implement laws and policies against human trafficking;
- To generate evidence on human trafficking to inform right holders and stakeholders;
- To strengthen network and capacities of the civil society organizations working against human trafficking and on human rights, particularly women's and children's rights;
- To develop AATWIN as a national level Resource Center against human trafficking;
- To build capabilities of AATWIN members and staffs on the ever-changing scenarios of human trafficking.

MAJOR PROGRAMS OF AATWIN

Advocacy Campaign against Human Trafficking

AATWIN has been executing awareness and advocacy campaigns targeted to formulation, effective implementation, improvement and reform of existing laws and policies based on due analyses of human rights issues from human trafficking perspective. Its main activities include lobbying, consultations, interactions, workshops, memorandum, press conferences, press release, demonstrations, sit-in-protests and rallies.

Network Building

AATWIN, realizing the significance of network in the fight against human trafficking, has been building networks at local, national and international levels. It is expanding its networks at the districts through its member organizations. Likewise, it has been building linkages with regional and international networks by becoming member of GAATW, RECEM/SDG, SAIEVAC/NACG

Conceptual Clarity Initiatives

Conceptual clarity on right based approach, changing trends and dimensions of human trafficking is important for AATWIN member organizations and stakeholders. It carries out variety of activities such as research, workshops, interactions, orientations, training and trainer's training including publications of different information, education and communication materials on different aspects to create awareness among stakeholders.

Information and Resource Center of AATWIN

The Information and Resource Center was established in 2004 with the objective of systematic collection and dissemination of information relating to human trafficking and human rights at the national and international levels. It has collection of books, journals, magazines, reports, research findings, bulletins, newspaper compilations, audio/visuals, posters, booklets, pamphlets, photographs, articles, flyers, and others. It also produces '*Osarposar*', a bi-annual publication, on various issues against human trafficking.



ORGANIZATIONAL ACTIVITIES 2019

AGM and Convention of AATWIN

AATWIN's 16th AGM and 8th Convention was held on 25th September 2019 at Buddhanagar, Kathmandu. The inaugural session was chaired by Ms. Anjana Shakya, Chairperson of AATWIN and the program was conducted by Ms. Samjha Shrestha, General Secretary. Guests of this session were advisors of AATWIN- Mr. Gauri Pradhan, ex-member, NHRC, Ms. Bishu Maya Bhusal, advocate, Mr. Tanka Panta, senior journalist as well as ex-chairpersons of AATWIN, Ms. Bishnu Ojha, Ms. Indira Phuyal, Ms. Laxmi Karki, Ms. Devi Adhikari, Ms. Meena Bista and representatives from Anti-Human Trafficking Bureau (AHTB) and District Coordinating Committee.



AATWIN's 3-year Organizational Development and Strategy Plan was endorsed in this AGM. The proposals for the new memberships of AATWIN were presented by New Membership Recommendation Committee and new membership was given to Kumudini Nepal. The membership of Women Awareness Forum for Social Change (WAFS), Kailali was terminated through this AGM as WAFS has not renewed its membership for the last three years. The Directive for the membership and Statute of AATWIN was also amended and approved.



The new executive committee of AATWIN for next two years was also elected. The leadership of AATWIN has been taken by Ms. Natisara Rai, who is a trafficked survivor rescued in Mumbai, India in 1996 and one of the founders of Shakti Samuha and founder and executive director of Shakti Milan Samaj. Among the nine members of executive committee, three members including the chairperson are from the survivors' organizations.

Regular Quarterly Meetings

In every three months, AATWIN holds a regular quarterly meeting of member organizations. In these quarterly meetings, AATWIN update the members about the programs and activities, discuss the upcoming activities, and enhance their understanding of joint objectives, goals and areas for advocacy. The meeting also provides an opportunity for members to learn from each other and learn about anti-human trafficking initiatives, share challenges and enhance coordination.

In quarterly meeting held on 8th February, a private sector partner of “Hamro Samman” project National Business Initiatives (NBI) did a presentation on the opportunity for collaboration on sustainable livelihood for trafficking survivors, intending to enhance the coordination between NGOs and the private sector. One of the objectives of “Hamro Samman” is to enhance private sector partnership to support TIP survivors and at-risk population. The other quarterly meetings were held on 25 June and 6 September 2019.



Mobilization of Resource Centre

During January to December 2019, AATWIN Resource and Information Center distributed 18,995 IEC materials were published by AATWIN and collected from different agencies and received 1,981 new IEC materials were received and collected from other various organizations. 85 new visitors visited the resource centre. AATWIN mobilized information and resource center with the objectives to produce, collect and disseminate information related to human trafficking, slavery, child rights and human rights in a systematic way and disseminating the information at the national and international level regularly.



Commemorating Days



109th International Women's Day (8 March) 2019

The international theme for 109th International Women's Day was "Think equal, build smart Innovate for change". AATWIN participated in the rally organized by MoWCSC to mark the day and also participated in different programs. The national slogan for the day was "Equal thought and practice for gender equality - Basis for prosperity".

13th National Day Against Human Trafficking Day, 2019 (20 Bhadra 2076)

13th National Day against Human Trafficking was commemorated on 6 September 2019. AATWIN was also member of main organizing committee of the Government of Nepal and participated in the rally and the program organized by MoWCSC to mark the day. AATWIN organized a coordination meeting to organize rally with civil society organizations. As a result, there were more than 750 people participated in the rally. The Ministry honored individuals and organizations working against human trafficking for their efforts.



16 days of activism against Gender-Based Violence (25th Nov- 10th Dec) 2019

The 16 Days of Activism against Gender-Based Violence is an annual international campaign that kicks off on 25 November, the International Day for the Elimination of Violence against Women, and runs until 10 December, Human Rights Day. AATWIN participated in the rally to mark the first day of 16 days of Activism organized by National Women Commission. AATWIN also started a Facebook campaign urging the prompt ratification of UN TIP Protocol throughout these 16 days. AATWIN's member organizations and Executive Committee have been supporting this campaign.

71st International Human Rights' Day (10 December) 2019

71st International Human Rights' Day was observed on 10th December 2019. AATWIN and its member organization participated in the rally organized by NGO Federation. 71st International Day focused on universal call to action "Stand Up for Human rights," calling for youths all over the world stand up for rights and against human trafficking, racism, hate speech, bullying, discrimination, and climate change, to name a few.

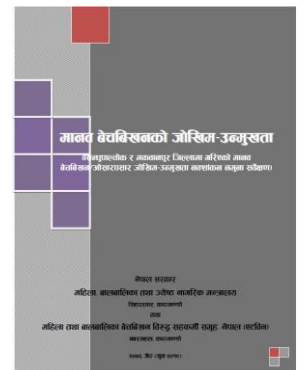


Research

Pilot Survey for Mapping Vulnerability to Human Trafficking in Sindhupalchowk and Makwanpur (2019), AATWIN and MoWCSC

AATWIN conducted the pilot survey for mapping out at risk and vulnerable to human trafficking in the two districts, Sindhupalchowk and Makwanpur. The survey was supported by Ministry of Women, Children and Senior Citizens.

The objectives of the study are to identify most vulnerable persons, communities and territories at the risk of human trafficking occurring in and outside the country. This survey also tends to study the inter-relation between social-economic situation and vulnerability to human trafficking and income level, employment, educational status, race and place; and to present recommendations on prevention, minimizing risk for human trafficking and suggestions on measures to be adopted for controlling human trafficking.



Publications

First E-Newsletter of AATWIN

The first edition of e-bulletin was developed in the month of April. AATWIN disseminated it on 29 and 30 April, 2019. AATWIN publishes e-bulletin with the objective of sharing information with stakeholders about AATWIN's activities including advocacy initiatives, learnings and result, different human trafficking campaigns, and other CTIP issues.

In this edition AATWIN shared the various activities details done with the support of "Hamro Samman" and AATWIN's other existing projects. The bulletin covered the activities from the month of July, 2018 to November, 2019. It was disseminated to member organizations and other stakeholders. E-bulletin was shared with 40 AATWIN members and 39 other stakeholders including INGOs, NGOs and GOs.



Half yearly bulletin Osarpasar

AATWIN has been publishing half-yearly bulletin entitled "*Osarpasar*" since 2001. This year 18th issue of the bulletin was published and the theme was "Access to Justice for Victims/Survivors of Human Trafficking. The bulletin includes the issues relating to access to justice for trafficked victims in Nepal and its challenges, the current situation of human trafficking, the provisions in new laws against human trafficking. This issue of *Osarpasar* also includes representative case studies of different kind of trafficking like, organ trafficking, sex trafficking, child trafficking, labour trafficking, and internal trafficking. The bulletin has been serving as a tool for sensitization and advocacy with various stakeholders.



Five Years Media Analysis Report on Human Trafficking

Research and documentation has been one of the major activities of AATWIN. As a part of its documentation activity, AATWIN has been managing the clips of news and articles related to human trafficking published in newspapers and have been analyzing the trafficking news and sharing it with wider stakeholders. This media analysis is an attempt to analyze the coverage of the news and articles in the newspapers published. It has not just analyzed the coverage but also looked at the priority of news and articles on human trafficking, unsafe migration, maintenance of confidentiality in the news and articles and other dimensions of human trafficking as reported in the newspaper



AATWIN published a book titled "Dimensions of Human Trafficking", five years (2069-2073 BS) comparative media analysis report of human trafficking on November 2019. This research report is the evidence for lobby and advocacy to the governments for AATWIN or other likeminded organizations for the prevention, control and reduction of human trafficking. The report will be helpful for necessary legal reforms including for the protection of survivors and witness protection. The report will also enable to identify recent trends, changing dimension of human trafficking and its causes, vulnerable for all those concerned in particular- the government, national and international actors, researchers, students and organizations working in this sector.

Facebook Campaign for Ratification of Palermo Protocol

On 27 June 2019, Nepal's Council of Ministers recommended ratification of the United Nations Protocol to Prevent, Suppress and Punish Trafficking in Persons Especially Women and Children also called Palermo Protocol. AATWIN has been advocating for the ratification for a long time and continued its campaign and launched a Facebook Campaign for ratification of Palermo Protocol throughout the month of July marking World day against trafficking in person (30 July) to make that recommendation a reality. AATWIN continued this campaign during the Nepali month of Bhadra, commemorating National Day against Human Trafficking (20 Bhadra) as well as during 16 days of Activism against Gender-Based Violence. AATWIN member organizations and other CSOs also showed their solidarity to the campaign by providing the photos. Ratification will help better define human trafficking in Nepal and lead to better prevention, protection and prosecution of the crime.

Delegation Visit and Meetings with Concerned Authorities/Stakeholders

In 2019, AATWIN organized delegation visits and meetings with concerned authorities to advocate on important issues of human trafficking.

AATWIN advocated the following important issue of human trafficking in memorandums:

1. Amendment in Human Trafficking and Transportation (Control) Act 2007 and Regulation 2008 and Children Act according to the federal system.
2. Immediate ratification of Protocol to Prevent, Suppress and Punish Trafficking in Persons Especially Women and Children (Palermo Protocol), supplementing the UNCTOC
3. Formulation of new "National Policy against Human Trafficking"
4. Formulation of guideline/regulation for rescue and repatriation of victim/survivors of human trafficking
5. Formulation of relevant laws and mechanisms to end labor and sexual exploitation of women and adolescents in the entertainment and informal sectors.
6. Amendment of the National Plan of Action Against Human Trafficking, 2011



AATWIN Delegation to Hon. Minister Tham Maya Thapa, MoWCSC

AATWIN organized a delegation visit to Ministry of Women, Children and Senior Citizens (MoWCSC) on 26th June 2019. Ms. Anjana Shakya, Chairperson of AATWIN submitted the recommendations for the amendment of Human Trafficking and Transportation (Control) Regulation 2065 to Honorable Tham Maya Thapa, Minister of MoWCSC.

After the meeting, Hon. Minister shared that, MoWCSC is in the process of amendment of Human Trafficking and Transportation (Control) Regulation 2008 and committed the suggestions and feedback would be incorporated. She also shared with AATWIN delegation team that the Council of Ministers has decided to ratify the UN TIP Protocol.

Delegation to Chair and Members, NHRC

AATWIN's delegation to National Human Rights Commission (NHRC) submitted the memorandum for the contemporary issues of human trafficking to NHRC Nepal Chairperson and Members on 17 July 2019 at Pulchowk, Lalitpur.





Delegation to Parliamentarian Committee on Women and Social Development

AATWIN team also visited Hon. Niru Devi Pal, Chairperson of Parliamentarian Committee on Women and Social Development on contemporary issues of human trafficking and for ratification of Palermo protocol on 2nd August 2019. Hon. Pal stated she is aware of the Palermo Protocol, committed to raise issue in the Cabinet for its ratification.

Delegation to Hon. Minister, Parbat Gurung, MoWCSC

AATWIN Delegation Team led by Chairperson Ms. Natisara Rai handed over a Memorandum to Hon. Parbat Gurung, Minister for Women, Children and Senior Citizen on the contemporary issues of human trafficking need to address by MoWCSC on 26 December 2019.

Hon. Parbat Gurung expressed that the Ministry is willing work together towards ending human trafficking, for this, he committed to amend the existing laws and also formulate new laws and national policies if required. He also expressed his commitment to working with private sectors and NGOs to minimize the trafficking.



AATWIN's Movement for Access to Justice for Trafficking Survivors

Ward chairman of Dupcheshwore-1, in Nuwakot Sun Bahadur Tamang, sentenced by the Nuwakot District Court for 37 years on charge of trafficking women, has been acquitted by the Patan High Court. The high court overturned the district court verdict of March 19, 2018 and gave clean chit to Tamang. He was in the jail for the fourth case about trafficking of women after being released on bail in two cases about trafficking and through habeas corpus by the Supreme Court (SC) in the other.

Coordination meeting regarding Nuwakot Trafficker Case

AATWIN organized a coordination meeting on 31st July 2019 with CSOs working against human trafficking to discuss about the Nuwakot trafficker case. 43 participants representing 30 CSOs were present in the meeting. Everyone present in the meeting was of one opinion that all should collaborate and coordinate to bring the perpetrator to justice and legal team was formed consisting of FWLD, LACC, CELRRD and PPR to study the legal documents and provide legal consultation, the team would be led by CELRRD. AATWIN will facilitate and coordinate for the support required.

AATWIN also shared about the delegation visit to various government agencies like NHRC, MoWCSC, Office of Attorney General, Anti-Human Trafficking Bureau, Central Investigation Bureau, Parliamentarian Committee on Women and Social Development to handover the Attention Letter for protection and justice to victims.

Delegation to Various Govt. Stakeholders regarding Nuwakot Trafficker Case

AATWIN organized a delegation visit to raise the concern and handover attention letter to Hon. Mohana Ansari Member of National Human Right Commission on 22nd July; Mr. Chandra Prasad Ghimire, Secretary, MoWCSC on 23rd July; Mr. Agni Prasad Kharel, Attorney General on 24th July; SP Ishwor Babu Karki, Director of Anti-Human Trafficking Bureau (AHTB) on 25th July; SSP Umesh Raj Joshi, CIB on 28th July; and Hon. Niru Devi Pal, Chairperson of Parliamentarian Committee on Women and Social Development on 2nd August for justice to victim and punish the trafficker.



After the submission of the memorandum the following reaction was made by the authorities:

- **Hon. Mohna Ansari** said that NHRC could not create the pressure to the court but expressed her solidarity to this campaign and also suggested AATWIN to raise this issue in various other platforms.
- **Mr. Chandra Prasad Ghimire** expressed that this is a very serious issue on which MoWCSC is always ready to support the victim in this case.
- **Mr. Agni Prasad Kharel** stated that this case will be appealed in the Supreme Court by the High Court Attorney. He emphasized the need to empower the survivors/victims and also queried if the victims could be brought in contact with the Office of Attorney General.



- **SP Ishwor Babu Karki** stated that as the AHTB was especially established to investigate the trafficking issue and during the process of the case, if any kind of support is needed, he expressed the commitment of support from AHTB on this case.
- **SSP Umesh Raj Joshi** said that CIB started the cases against Tamang and done investigation in the past, if any help is needed, CIB is ready to help.

OTHER MAJOR ACTIVITIES OF 2019

Closed Session Interaction with Right-Holders of Entertainment Sector

AATWIN conducted a closed session workshop with female workers from entertainment sectors on 3-4 April 2019 at Dhulikhel, Kavrepalanchowk. The main objectives of the workshop were to understand the current working situation of entertainment sectors, including the difficulties and challenges faced by female workers, and to identify the issues, problems and generate evidence for further advocacy and lobbying for reform and enactment of laws and policies against internal trafficking and exploitation in the entertainment sector.

19 participants, right holders/female workers from entertainment sectors participated from nine various organizations (Biswas Nepal, Change Nepal, WOFOWON, Shaki Samuha, Chhori, CAP Nepal, YST Nepal, Raksha Nepal and SASANE).

The participants were oriented about their rights as well as on human trafficking and potential vulnerabilities. They felt empowered through the workshop as they got to learn from one another's experience as well. The problems and situation of exploitation are still grim. However, during the workshop, some of the positive changes were also shared by workers like the owners/employers have started providing identity cards (36 %) and appointment letter (10%) to the workers, drop off facilities as well as receiving the salary on time (50%).



Dialogue with Government Stakeholders

AATWIN organized a dialogue with Government Stakeholders on CSEC and internal trafficking in entertainment sectors was on 29th April 2019 in Kathmandu to enhance the coordination with government stakeholders in order to reduce child labour from the entertainment sector, make decent and regulate the entertainment sectors.

There were total of 39 participants including 15 government officials from MoWCSC, NHRC, National Women Commission, Nepal Bar Association, Anti Human Trafficking Bureau, Central Child Welfare Board, Department of Labour and Occupational Safety, Kathmandu Metropolitan City, Lalitpur Metropolitan City, Tokha Municipality, Labour Office, Cottage Industries Office, Office of Attorney General, Lalitpur District Attorney and 24 representatives from CSOs attended the program.



The Anti-Human Trafficking Investigation Bureau (AHTB) was established on 4th Feb. 2019. This is a special unit to investigate human trafficking cases. The detail information about the Bureau was given by Mr. Anupam SJB Rana, SP. Representative from Department of Labour committed that the monitoring visit of entertainment sectors will start in future.

TOT against Human Trafficking from Human Right Perspective

AATWIN organized a Training of Trainers (ToT) for its member organizations from 7 to 10 May 2019 at Godavari, Lalitpur. The main objective of the training was to capacity development of member organisations in combating human trafficking by enhancing the conceptual clarity on human trafficking and its different connects.

The major contents of training were conceptual clarity on various terminologies related to human trafficking, human smuggling, national and international definition of human trafficking and its situation, changing dimensions and trends of human trafficking, human rights-based approach and different national and international laws against human trafficking.

There were 27 participants from 9 geographical areas - Kathmandu, Lalitpur, Kanchanpur, Kailali, Makwanpur, Sindhupalchowk, Kapilvastu, Dang and Morang in the training.



Consultation on Amendment of HTTC Regulation, 2008

A bill to amend the Human Trafficking and Transportation (Control) Act was tabled in the Federal Parliament in January 2019. This amendment had made only a few changes to operate the Rehabilitation Centre for the survivors/victims of human trafficking. However, there are still not adequate protection mechanisms from local to national level, to address the protection and security for people affected by trafficking. On this context, AATWIN organized a consultation workshop on “Amendment of Human Trafficking and Transportation (Control) Regulation, 2008 in the Federal System” on 23rd May 2019.



The main objectives of the program were to make the Human Trafficking and Transportation (Control) Regulation victim/survivor friendly and recommend for amendments in the Regulation as per the new federal structure of Nepal. The chief guest of the program was Ms. Rudra Devi Sharma, Joint Secretary of Ministry of Women, Children and Senior Citizen. Advocate Kapil Aryal was the resource person of the program. Total participants of the program were 66 including 12 representatives from government offices i.e. NHRC, NWC, MoWCSC, Department of Labour and Occupational Safety, Office of Attorney General, District Attorney Office, Anti Human Trafficking Bureau, Special Police Unit for Women and Children, Kathmandu.

The participants gave constructive feedback on the structure of different committees and their roles and responsibilities, the operation procedure of rehabilitation centre and emergency shelter, and matching fund to support the survivors of human trafficking. Joint Secretary committed that these important suggestions and feedback will be incorporated in the Human Trafficking or Transportation (Control) Regulation, 2065 and the Regulation will be referred to the Ministry of Law, Justice and Parliamentary Affairs soon.

Advocacy Program at Federal Level against Human Trafficking and CSEC

AATWIN organized an interaction program with Federal Members of Parliament on 'Human Trafficking and CSEC and Role of Federal Level' on 24th May 2019 in Kathmandu, The resource person and the facilitator of the program was Mr. Gauri Pardhan, Former member and spokesperson of NHRC. Total of 60 participants were in the program including 12 members of the Federal Parliament.



The main objective of the program was to sensitize the members of the Federal Parliament on the new trends of human trafficking and CSEC issues and lobby to ratify the UN TIP Protocol and amend the Human Trafficking and Transportation (Control), Act (2064) and Human Trafficking and Transportation (Control), Regulation, 2065 to allocate the budget, implement the federal laws on human trafficking. Members of Parliament committed to raising the issues- ratification the UN TIP Protocol, amendment of Human Trafficking and Transportation (Control) Act, 2064 and Human Trafficking and Transportation (Control) Regulation, 2065 at the next Federal Parliament session.

Interaction Program on 'Human Trafficking and CSEC in Entertainment Sector – Problems and Solutions'

AATWIN organized an interaction program to share and discuss the problems and solution of CSEC and human trafficking in the entertainment sector on 24th June 2019 in Kathmandu. The major objective of the program was to share the findings of the closed session workshop with the female workers of entertainment sector, which was conducted in April 2019.

Ms. Neelam Sharma, the facilitator of the workshop presented the findings of closed session workshop in the interaction program along with role of workers, employers, government agencies, trade unions and CSOs. The representatives from the Ministry of Labour, Employment and Social Security (MoLESS), MoWCSC, AHTB, Trade Union, AATWIN members,



various CSOs and journalists were present in the program.

In the closed session workshop, workers suggested that the government agencies should play the roles to make entertainment sector decent and regulated. They also suggested that, the local government should make mandatory provisions for registration and renewal of each business, conduct the regular monitoring in continuous basis, strictly prohibited the illegal activities, all police should be oriented and sensitize on entertainment sectors' issues, proper and effective implementation of Labour Act, 2074. The participants suggested that, owner of the entertainment sector should recruit only adult staff, provide job description, appointment letter, identity card, leave facility, minimum salary, festival allowances, insurance and transportation facility to the employees.

Dialogue with Business Institutions (Private sector) to reduce CSEC

AATWIN organized an interaction program "**Role of Private Sectors to Make Decent and Regulated the Entertainment Sector**" in coordination with Metropolitan Police Range, Kathmandu (annexes Kalimati and Kalanki) under Community-Police Partnership Program on 20th August 2019 at Kalanki. The total of 165 participants including 103 adult entertainment sector owners/employers attended the program. Hon. Krishna Gopal Shrestha, Member of the Federal Parliament was the Chief Guest of the program and Ms. Shova Sapokata, Chairperson of Kathmandu Metropolitan City Ward no. 14 chaired it. Ms. Anjana Shakya, Chairperson of AATWIN highlighted the objectives of the program and



emphasized that all kinds of work is respected in the developed countries. The entertainment sector has been providing employment to thousands of people.

DSP Rajendra Pokharel did a presentation on legal provisions to regulate the entertainment and shared observations of the monitoring visits to entertainment sectors. He also highlighted the roles and responsibilities of employers for creating regulated and safe work place. The second presentation was on

situation of the workers of the sector and expectations of the entertainment sector workers from their owners by Ms. Benu Maya Gurung, AATWIN. She also raised issues of identity card, appointment letter as well as abuse, labour and sexual exploitation faced by the workers.

Enhancing Coordination

An interaction program "Human Trafficking and CSEC: Situation and Way Forward" was jointly organized by the Ministry of Women, Children and Senior Citizen (MoWCSC) and AATWIN on 23 October 2019 at Singhadarbar to enhance coordination among the CSOs as well as with MoWCSC, learn about the current situation of human trafficking and CSEC and to find a way forward to reduce it through collaborative effort..

The program was chaired by Hon. Thama Maya Thapa, Minister for Women, Children and Senior Citizen and was moderated by Ms. Rudra Devi Sharma, Joint Secretary of the Ministry. Ms. Benu Maya Gurung, ED of AATWIN did a short presentation on the issue of human trafficking and CSEC. There were total of 68 participants from various. Ms. Sharma shared that MoWCSC is preparing a roster of CSOs and the



networks to map out the CSOs working against human trafficking and asked all the present CSOs to send their profile and information to Ministry. She also added that HTTCA 2007 and Regulation 2008, both are in the process of amendment.

Hon. Minister Tham Maya Thapa shared that the Government of Nepal has declared the year 2076 BS as the year for campaign against gender-based violence and the Ministry has set the motto for the campaign as “End of gender-based discrimination, goal of a prosperous Nepal”. She further added that the each level of government should take initiation to put an end to all kinds of gender-based violence, prevent human trafficking and form an active action committee for this. She also highlighted that the CSOs should give the concrete feedback to the governments what types of program is needed to reduce the human trafficking. Hon. Thapa requested AATWIN for brochures on human trafficking and safe migration to be disseminated in all seven provinces during the 16 days campaign against gender-based-violence.

Media Analysis 2075 Report and Its Sharing

Media monitoring of 11 national newspapers including nine national dailies and two magazines was conducted by AATWIN in year 2075 BS (between 14 April 2018 and 13 April 2019). The main objective of the study is to find out dynamics and situation of human trafficking and to study causes of human trafficking on the pretext of foreign employment. The analysis was done and presented by journalist Mr. Bijay Paudel.

According to the report, there were 227 media coverage on human trafficking during the period. The media monitoring used 19 indicators such as numbers of news published, caste, age, gender, permanent residence of the victims of human trafficking, cause of human trafficking and date of news reported. The newspapers and magazines reported that 54 per cent of trafficking was cross border trafficking. It was also reported that twenty-six per cent of trafficking took place in the name of foreign employment.

Of the total reports on human trafficking, 50 per cent were about people in the age group 0-17 while 41 per cent of the reports were of the people between 18-29 age. The report revealed that higher number cases of women trafficking was reported (86 per cent) compared to males (14 per cent). The number of male victims is low as men do not want to reveal their exploitation through human trafficking. The report also revealed that media violated the code of conduct by disclosing the names of the victims, their address along with parent’s names.



Orientation on New Laws to AATWIN members and other stakeholders

Orientation on New laws on Human Trafficking, CSEC and Rights of the Victims was organized on 4-5 November 2019 at Nagarkot, Bhaktapur, Nepal. The total participants were 46 persons from government and AATWIN member organizations.

The main facilitator of the program was Mr. Tek Narayan Kunwar, High Court Judge, who was awarded with Trafficking in Person (TIP Hero) by the US Department of State in 2014¹. The other facilitators of the program were Advocate Dilip Koirala and Advocate Bal Maya Bishwakarma. Ms. Benu Maya Gurung, Executive Director highlighted about the main features of Human Trafficking and Transportation (Control) Act, Children's Act, Muluki Criminal (Code) Act 2074 and Labour Act, 2074.



The legal orientation covered the topics on:

- Provisions in HTTCA 2007 and Regulation 2008, procedures to register cases for prosecution, rights of the trafficked victims
- Provisions and procedure to register cases under Sexual Harassment in the Workplace (Prevention) Act, 2071.
- Major provisions in Labour Act 2074 against labour exploitation and procedure to register cases under the Act.
- Provisions in Criminal Code, 2074 against slavery, exploitation, the rights of a victim and legal procedures
- Provision in Children's Act 2075 regarding child rights (Right to life, development, protection, participation and against discrimination), prioritizing the best interests of children, considerations during juvenile justice, special protection and rehabilitation of children, crimes against children
- Good practices, challenges, and solutions to the issue of human trafficking and CSEC

Team Spirit Building and Policy Formulation Workshop

“Team Spirit Building and Policy Formulation Workshop” was organized from 7-11 November 2019 at Bhairahawa, Rupandehi district. The Executive Committee (EC) Members and the secretariat staff participated in the workshop.



Discussions were held on the draft Safeguarding Policy and Terms of Reference (ToR) of different committees: advisory, management, policy analysis and advocacy, organizational development and mobilization, internal audit, procurement, monitoring and evaluation, publication and new membership referral. The policies were drafted and presented by consultant Mr. Shuvendra Man Shrestha.

Team Spirit building exercises were also conducted to enhance coordination and better understanding among staff and EC members through various games. Like the famous quote by famous American author Heller Keller- “Alone we can do so little, together we can do so much.” The exercises enabled the team to understand the team building is a very crucial process, to take any organization to greater heights and work towards the goals assigned, a good team is a must.



During the workshop in Rupandehi, the AATWIN team also visited its member organization Aafanta (KIN) Nepal's field office in Rupandehi and information booth at India-Nepal border area at Belahiya, Bhairahawa to learn about the cross-border trafficking issues.

Dialogue with Mediaperson

AATWIN and Biswas Nepal jointly organized a dialogue with media persons to end human trafficking and CSEC on 26 December 2019 at New Baneshwor, Kathmandu. The significant number of journalists from various media for instance, Nepal Television, Kantipur Television, Image Television, Sarokar Television, Gorkhapatra, The Kathmandu Post, Annapurna Post, Nayapatrika, Himalkhabar, Khabarhub, Radio Upatayka, ONS News online, Media Advocacy Group, Nepal Readers.com etc. The program was also covered in various medias.^{2 3 4 5 6 7.}

The main objective of the program was to sensitize mediapersons on issues of human trafficking and CSEC. Ratification of Palermo Protocol, amendment of HTCA 2007 and Regulation 2008 as per new structure of country, formulation of repatriation guideline and victim/survivor friendly polices, safe migration, foreign employment and changing trends and dimensions of human trafficking, regulation of entertainment sector and internal trafficking, effective coordination and cooperation among private sectors, media, CSOs and other stakeholders was discussed during the interaction. A female worker from entertainment sector shared the problems and challenges of this sector

ACTIVITIES IN JOINT COLLABORATION

4th National Conference of Human Trafficking Survivors, 2019

The Fourth National Conference of Human trafficking Survivors was organized by AATWIN and Shakti Samuha on 4-5th September 2019 at Staff College, Lalitpur. AATWIN has been engaged as the co-organizer since the first conference. Organized on the occasion of 13th National Day against Human Trafficking, it was attended by 103 survivor participants from all seven states, whereas total of 303 various stakeholders attended the program.

The objective of the conference was to bring together human trafficking survivors and form a national and state level networks survivors and empower them. The network will lobby against human trafficking issues and will work towards ensuring the legal, economic, social and cultural rights of trafficked survivors.

The Opening Ceremony: The program was inaugurated by the chief guest of the opening ceremony Hon. Tham Maya Thapa, Minister for Women, Children and Senior Citizens and chaired by Ms. Balkumari Darlami, Chairperson of Shakti Samuha. Other special guests present at the program were Hon. Shashi Shrestha (Chairperson of State Affairs and Good Governance Committee of Parliament), Hon. Niru Devi Pal (Chairperson of Women and Social Committee of Parliament), Dr. Renu Adhikari (activist and ex-chairperson of AATWIN).



Parallel Session: After the inauguration session, the parallel session discussions were held on major four issues of trafficking survivors. The sessions were conducted on:

1. Rescue, Repatriation, Reintegration and confidentiality of Human Trafficking Survivors
2. Access and Participation of Human Trafficked Survivors in New Federal Structure
3. Access to justice for survivor of human trafficking
4. Issues of mental and physical health, as well as Sexual and Reproductive Health and Rights (SRHR) amongst human trafficking survivors.

After the parallel sessions, the reporters of the all the session and the declaration committee members had a discussion. The issues raised in all the sessions were compiled together and the declaration/memorandum was drafted.



Survivors' National Network Building: The networking building session was facilitated by Ms. Anjana Shakya and Ms. Balkumari Daralami and was supported by Ms. Bhagwati Nepal. The importance of network of the survivors for the survivors was underlined. The first national-level network of Human Trafficking survivors was

formed and Ms. Charimaya Tamang was chosen as the coordinator of the network. The committee of 17 members formed during the conference, would also proceed with the task of forming each of the seven state-level networks. The national network will work closely with the Government of Nepal and locally-elected officials to address issues related to protecting the human rights of survivors, women and children. Furthermore, the network will work to strengthen the overall legal provisions and services related to the prosecution of traffickers and the rescue, rehabilitation and repatriation of trafficking survivors. Coordinator Tamang said, "The network will also act to create pressure on the government of Nepal to rescue the victims and survivors of human trafficking and to return them back home as quickly as possible."

Closing Ceremony: The closing ceremony was held on the second day of Conference and the chief guest of Closing Ceremony was Hon. Anup Raj Sharma, Chairperson of National Human Rights Commission (NHRC). The 22-points Declaration was handover to the chief guest and the other special guests at the Closing Session. All the guests present in the dais commended the conference, the first national network of human trafficking survivors and importance of this platform as well as they committed towards working together in countering trafficking in persons.



Submission of Declaration to NHRC, MoWCSC and MoHA:

During the main ceremony to commemorate National Day against Human Trafficking on 6th September 2019 organized by Ministry of Women, Children and Senior Citizens Ms. Anjana Shakya, Chairperson of AATWIN was chosen to give a speech on the behalf of all Civil Society Organizations. Ms. Shakya spoke about the contemporary issues of human trafficking, ratification of Palermo Protocol and Fourth National Conference of Human Trafficking. Ms. Balkumari Daralami of Shakti Samuha handed over the 22-points Declaration issued by the conference the Chief Guest of the ceremony Hon. Ram Bahadur Thapa (Minister for Home Affairs), Hon. Tham Maya Thapa (Minister for Women, Children and Senior Citizens), Hon. Niru Devi Pal, (Chairperson of Women and Social Committee of Parliament) and IGP Sabindra Khanal.

Press Conference: The first National Network of Human Trafficking Survivors organized the press meet on 6 September 2019 (20 Bhadra 2076) at Reporters' Club, Pradarsani Marg.



The new network took this opportunity to share about the two-day conference of human trafficking survivors and its achievement. It also issued a press release and shared 22-point memorandum with the media. More than 20 media houses attended the press meet and interaction was very fruitful between new network and media.

Project: Strengthening Advocacy to Prevent Internal Trafficking (SAPIT)

Internal Trafficking is significantly prevailed in entertainment sector and workers are victimized. The Nepalese laws and policies are not adequately addressing the internal trafficking problems.

AATWIN as a national network of NGOs aims to influence its member organizations for taking proper actions on addressing vulnerabilities and support for internal trafficking victims, survivors and vulnerable. AATWIN also intends to influence the government authorities for addressing internal trafficking in entertainment industries through proper legal, policy measures and mandated mechanisms.

Objectives: Influence stakeholders', both government and non-government sector, engagement on addressing and taking actions internal trafficking and commercial sexual exploitation of children in Nepal through legal, policy and programmatic measures.

Project: Hamro Samman
Partner: Winrock International, USAID, UKAID

The Hamro Samman project is a five-year project with financial support from the American people through the United States Agency for International Development (USAID) and implemented by Winrock International. Its goal is to reduce the prevalence of trafficking in persons (TIP) in 10 strategically selected districts of Nepal. Using the '4Ps' framework-Prevention, Protection, Prosecution and Partnership, the Hamro Samman project will bring together various stakeholders and implementing partners to reduce the prevalence of trafficking in persons through the following objectives:

- Strengthening national and local Government of Nepal (GON) efforts to combat TIP;
- Improving CSOs advocacy and engagement to address TIP; and
- Increasing private sector partnerships (PSPs) to service TIP survivors and at-risk populations.

Project: PROTECT Project (Missing Child Alert Phase II)
Partner: Plan International Nepal

Missing Child Alert (MCA) Phase 1 was an innovative and foundational pilot program, identifying the regional and national needs related to the protection of children, creating a unique solution and rolling out for testing and adoption a pilot program for state and non-state actors. MCA Phase 2, now called the ProTECT program, is a multi-year, comprehensive

project working directly with all major stakeholders within the targeted communities to ensure that there are comprehensive, holistic solutions (education and training, economic empowerment, systems strengthening) at all stages of the trafficking process, focusing on prevention (before trafficking), action during transit (during), and rehabilitation of survivors (after)."

Overall Objective: Educate, empower and equip adolescent girls and young women, families, communities, protective actors and local government with knowledge, capacity and resources to help protect vulnerable populations, prevent trafficking, respond to risks and in contributing developing a system for repatriation of survivors across India, Bangladesh and Nepal.
